Gartner Research pricing- Bob Moulton went over the Gartner pricing document. The top portion of the document showed the normal contracting price with the bottom being the price for Higher Education. SCS will be using the reference seat price of \$21,000 which would then allow other campuses to buy theirs for \$13,000. If campuses choose to use the Higher Education price they will have access to their core Research. Bob asked if anyone was interested in purchasing a seat at \$13,000. Lori Temple stated UNLV was interested.

Bob will ask SCS' Project Management Office to lead by taking an overall view of the project. Lori asked if Bob could have someone look into the listservs and issues related to listservs. Bob requested she send him an e-mail asking this question so he could route the answer to everyone.

Coordination of meeting schedules between the Advisory Group and the CTO committee- Lori stated the SCS Advisory Board and CTO meetings are too close to one another making it difficult to bring information to each group for a decent conversation. Lori requested to move the CTO meeting to the fourth Wednesday of each month. Everyone present agreed it would work for them. The next meeting will be on May 27th with every meeting from then on being on the fourth Wednesday.

Q & A: Steve Zideck asked Lori Temple if there was anything to report from the Advisory Board. Lori stated they reviewed SCS' response to the planning questions and have come up with some action items. Lori will send this information to the CTO's the following week. Bob will tentatively schedule Roberta to come to the next CTO meeting and present what SCS prepared for the Advisory Group.

Lori mentioned UNLV's Cabinet group has brought up the issue of electronic signatures. SCS has had prior experience with this and would like to know if it was possible to resurrect the topic. Bob will look into this topic some more.
